FOREIGN EXPERIENCE OF INCREASING THE IMPORTANCE OF LOCAL BUDGETS IN THE DEVELOPMENT OF SOCIAL SPHERE

Abstract

The study of foreign aid to increase the role of local budgets in the development of the social sphere is an important problem in the process of implementing processes related to the globalization of the economy in Uzbekistan. Because the purpose of the budget is to provide funds and develop social spheres by controlling the importance of the budget process. The article discusses the opportunities and some problems in using foreign experience.

In the world, the role of local state bodies in ensuring the socio-economic development of regions is significantly increasing. One of the most important means of implementing this role is the local budget, which is a fund of funds formed from the income of local government bodies and used to finance expenses aimed at improving the lives of the population.

Due to the global changes taking place in the world economy, the existence of a high level of uncertainty complicates the formation of the country's budget and the forecasting of the main macroeconomic indicators. As a result, many countries are moving to a decentralized management system, which further increases the role of the local budget in socio-economic development. For example, according to the International Monetary Fund, a 1% increase in local budget spending on infrastructure leads to a 0.7% increase in gross domestic product.¹.

In the medium-term development strategy of Uzbekistan, important tasks such as increasing the base of local budget revenues, ensuring their financial independence, and creating a competitive environment between regions are defined. it is important to study and apply their positive results in our republic. While thinking about the development of the regions, the President of the Republic of Uzbekistan Sh.M. Mirziyoyev says: "These areas have not been given such a large amount of funds to date. Now it needs to be delivered in an orderly, efficient manner. Therefore, it is necessary to introduce an electronic control system, linking the funds allocated for each program with target indicators."².

Achieving stable economic indicators in the conditions of economic globalization is first of all closely related to achieving stability in our life and economy. Therefore, stabilization of the financial situation of our economy is an important condition for the implementation of our economic reforms.

Today, in the conditions of ongoing serious problems in the global world economy, a number of measures are being implemented to effectively organize the budget and tax policy of the country.

The role of local budgets in the state budget system is the financial basis for the organization of local budget revenues and determining its composition.

Another of the available opportunities to increase the income of local budgets is related to the creation of opportunities to increase the economic activity of the population in these places, as well as the improvement of the mechanism of taxing the income of individuals from business activities. Rates of taxation of income from business activities of individuals are set independently by local authorities. The monetary income of the population includes all cash receipts in the form of wages, income from business activities, allowances, pensions, scholarships, income from property in the form of interest, dividends, rent, securities, real estate, agricultural products, crafts. and includes income from the provision of various services.

The world experience shows that gaining one's statehood, achieving national and social freedom has never been easy anywhere. Every country that has gained independence is looking for its own way of development, trying to develop its own model for building a new society. 


Figure 1. Contribution of social sphere expenditures to state expenditures³

In these countries, the state system of providing funds to the social sector is strongly developed. This system ensures that the general population enjoys many social benefits, which cannot be ensured with non-governmental social funds. So, even in developed countries, financing of the social sphere is included in the financial activity of the state.

In many developed countries, social sector spending is considered the main financial activity of the state, and they implement this financial activity through local budgets.

The main direction in regional budget expenditures will consist of funds spent on social and cultural objects. Primary and secondary schools are the primary expenses in this direction. In Germany, these costs make up 1/4 of local budget costs, in Japan and France more than 1/3, and in Great Britain and USA budgets more than 40% of costs.

In almost all of the countries of the Organization for Economic Co-operation and Development (OECD), education spending has increased slightly compared to national welfare spending. In France, Mexico, Norway, Spain, and Switzerland, public spending on education as a percentage of Gross National Product (GNP) increased from 0.5 percent to 1.4 percent between 2000 and 2010. In Mexico, this growth was the highest, from 3.2 percent in 2000 to 4.6 percent in 2010, reaching levels in the Netherlands and Great Britain. On the contrary, in Italy and Turkey, such costs have decreased sharply. In Finland, between 2000 and 2010, as GDP fell, education spending also fell. Finland is currently spending more of its national wealth on education than it was in 2000, according to government spending on education. In Italy and Turkey, the result was different, as the GNP increased, education expenses decreased.

The study of foreign experience on increasing the role of local budgets in the development of the social sphere is considered important in the process of reforms being implemented in Uzbekistan in connection with the globalization of the economy. Because the positive result of these reforms in the budget sphere is to provide social spheres with funds and develop them by increasing the importance of local budgets in budget processes.
