As a result of the reforms implemented in the educational system, including higher education, the changes taking place are becoming of great historical importance from the socio-political, legal, economic and spiritual point of view. In recent years, the issue of remuneration for the work of employees of higher education institutions and their promotion has taken a worthy place in the internal policy (social protection system) of our country. Because the decision of the President of the Republic of Uzbekistan "On measures to improve the remuneration system for employees of higher education and research institutions of the Republic" dated April 5, 2018 PQ No. 3655 is one of the main documents regulating the payment of wages. This decision, which will come into force from September 1, 2018, provides for a significant increase in the salaries of all (basic) basic positions of professors and teachers of 81 higher education institutions and 136 scientific research institutes operating in the Republic of Uzbekistan. holds The decision affects more than 38 thousand people, that is, 28.1 thousand employees in higher education institutions, 8.0 thousand employees in research institutions, as well as 1.9 thousand doctoral students [8].

#### 4. Conclusion

In conclusion, it can be said that the rise of attitude and attention to creative intellectuals in Uzbekistan to the state level and the fundamental changes in their activities were the result of the wishes implemented in the republic. In particular, it is known that on the direct initiative of the head of state, new aspects of these reforms, more appropriate aspects for the peace and well-being of the country are being developed.
