Since the 17th century, the creation of works that reflect the existence in forms similar to itself, while the trend of classicism prevailed in Fine Art, increased. The establishment of the academic education system ensured the development of professional art schools. A retreat from classic (classical) realistic (academic) art styles and a search for unconventional styles began. This situation was reflected in the formation and development of impressionism, postimpressionism and other styles.
