Abstract

Improving legal awareness and legal culture in society is one of the most important conditions for ensuring the rule of law and strengthening legality. Therefore, the Concept of Improving Legal Culture in Society was approved by the Decree of the President of the Republic of Uzbekistan No. PF-5618 "On Radical Improvement of the System for Improving Legal Awareness and Legal Culture in Society", signed on January 9, 2019.

Introduction

The adoption of the concept was caused by the following problems and shortcomings that hindered the formation of respect for human rights and freedoms, raising the legal consciousness and legal culture of the population, and increasing the level of legal literacy of citizens in society:

Firstly, the work on raising the legal awareness and legal culture of young people in society is not systematically and organically organized. There is no effective mechanism for conveying legal information in society, in the family, in the neighborhood, in educational institutions and organizations. The ideas of ensuring a balance between personal interests and the interests of society are not sufficiently instilled in the minds of the population, especially young people; secondly, educational processes in the continuing education system are not carried out in harmony with legal education, and the history, religion, traditions, and national values of the Uzbek people are not relied on in forming the legal culture of the population, especially the youth;

thirdly, in organizing events to improve legal culture, an effective system of cooperation with non-governmental non-profit organizations and other civil society institutions has not been created, and work has not been organized on the basis of the principle of social partnership; fourthly, specific targeted measures for forming legal immunity against factors that have a negative impact on the legal education of young people have not been established;

fifthly, the active participation of state bodies and other sectorial services in the organization and implementation of targeted legal advocacy activities in the society is not ensured, high efficiency and effectiveness in this regard are not visible;

Sixth, legal activities are still carried out in traditional ways, through simple meetings, innovative methods of propaganda, including web technologies, are not used in this regard, and legal websites are not enough;

Seventh, there are no legal mechanisms to encourage projects aimed at increasing legal literacy, and events in this regard are organized only in the name of events, and the publication and distribution of legal literature and scientific research to improve legal knowledge are being carried out ineffectively.

The main goal of the concept is to create a comprehensive systematic system of educating young people who have a strong will, who know their rights and respect the law, who can apply their legal knowledge in everyday life, who have an active civil position and who have an intolerant attitude towards crime.

The main tasks of raising legal consciousness and legal culture in society are:

to form a system of consistently conveying to young people the content and essence of socioeconomic reforms, adopted legal documents and state programs, to "establish the spirit of respect for the law in society - the guarantee of building a democratic legal state!" to strengthen the idea of life;

In raising legal awareness and legal culture in society, first of all, special attention should be paid to the systematic and coherent implementation of education and upbringing, starting from the preschool education system, instilling legal awareness and legal culture in young people, and promoting the ideas of maintaining a balance between personal interests and the interests of society;

to inculcate in the minds of the young generation the concepts of rights and duties, honesty and purity, as well as norms of etiquette, to teach them the important aspects of the Constitution from childhood;

To organize legal and educational activities to form a legal culture among the population in harmony with teaching the history, religion, and national values of our people, as well as to strengthen the sense of belonging to the country and patriotism by forming a sense of pride in state symbols in every citizen;

to raise the legal consciousness and legal culture of young people, to form in them an attitude of intolerance towards corruption and other offenses;

strengthening the cooperation of youth, law enforcement agencies and civil society institutions in the implementation of targeted legal advocacy;

to establish wide and productive use of the principles of social partnership on a systematic basis in the organization of activities to increase legal awareness and legal culture in society;

increasing the role of social networks and the media in providing legal information, and widening the use of innovative methods of legal advocacy, including expanding the use of web technologies;

among young people, as well as development of the system of training, retraining and upgrading of legal personnel;

an in-depth study of the scientific basis of raising the legal consciousness and legal culture of young people.

The main directions are:

- 1. Improving the legal culture of the population in the interaction between the individual, the state and society;
- 2. Introduction of innovative methods of legal promotion in raising the legal culture of young people;
